State of Kentucky Henry county set

On the 3rd day of December 1832 personally appeared in open court now sitting before the Justice holding court in the said county of Henry, state of Kentucky, it being a court of record - Andrew Collins, a resident of the county of Henry and state of Kentucky - aged seventy one years on the 22nd of October last past, who being first duly sworn according to Law, doth on his oath make the following declaration in order to obtain the benefits of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers & served as herein stated - to wit under Ensign David Sewel - Lieutenant William Nestle - Capt. Robert Lett and Major William Morgan - that he was drafted for three months & entered the service, as a private in the Virginia Militia - in the month April 1767 and served as a private as afd for the three months for which he was drafted - and that he & his whole company continued in the service & were not discharged until the first of Sept 1767 - making in all seven months, lacking a few days - that he resided in the county of Bartley in the state of Virginia, when he was drafted - & that his company marched from Manassasburg in said county in April 1767 as afd to Beason - to some now called Union town in the state of Virginia - & from thence to Potsdam from thence to Bohadays Cove, a place on the Ohio river about 20 miles above Wheeling in the state of Virginia - where we continued until the first day of Sept 1767 at which time we were discharged in part by Major Morgan - that he has long since lost his discharge - he further states that there was another company stationed at Beason's bottom on the Ohio river a few miles above Bohadays Cove & that Morgan had command of both companies - that there was about one hundred soldiers in both companies and that both companies were sent out to guard the frontiers against the Indians - that they had

no fighting, but that one of the men was taken
prisoner - In this town he well recollects that he
entered the service in April & that it was on the
18th day of Sept thereafter 1767 that he was discharged
but does not recollect the day of the month on which
he entered the service - for this term he only claims
three months pay -

That in October 1780 he was again drafted
for four months & in October ap^o he again entered
the service as a private in the Virginia militia
- that he entered under Lieutenant Whitneys Capt
Cuthbert Anderson - Of a Williams was his Colonel
that he does not remember the Number of the Regiment
- that his company commanded by Capt Anderson
marched from Berkeley County where he resided to
Hellsborough in North Carolina - thence to Salisbury
in North Carolina, thence to Cheraw Hills on Pedes
river where he found the main army, commanded
by Genl Green - of the other regular officers he
recollects a Maj. Boardman - This was in South
Carolina - that when Capt Anderson's company
reached the army, it was winter & that the army
wintered at the Cheraw Hills - that he continued
with the army until the month of February & that the
best of his recollection it was the first of February -
that his term of four months, for which he was
drafted, expired - that after his term expired
he & the said company, were retained in the
army for some time longer - & then his company
left the army commanded by Green, together with
some other companies, & marched back to the
state of Virginia to Winchester, that when they
reached Winchester it was in April 1781 and to
the best of his recollection, it was the middle
of the month of April & that he was discharged
at Winchester in April 1781 by Capt Anderson
in writing which he has long since lost - that in
this town he served, at least six months - that he
claims pay for six months for this term -

That after he returned home he was again, in July
1781, drafted for three months, as a private in the
Virginia militia - that he entered the service on
the 6th day of July 1781 under Capt. McCarter and
Lieutenant Throckmory - that he joined the army near
Williamsburg in the state of Virginia & remained with
the army in the neighborhood of Williamsburg
generally until the 6th of October 1781. Col. Dade
commanded his regiment he does not recollect the
Numbers of the Regiment, and Major Graves - A few
Days before he was discharged - Gen. Washington
& Lafayette joined the troops where he was -
together with the troops under their command
- on their way to Little York to be siege
Cornwallis - that he was discharged on the 6th day
of October 1781 verbally by Col. Dade - that he was
not in any battle, either of the towns that he
served - that he resided in the county of Berkeley
& state of Virginia each time when he was drafted
- that he was born on the 22nd day of October 1761
in the state of New Jersey, that his father
moved to Berkeley county Virginia in 1769 -
that his father had a book containing a
record of his age in N. & that he copied
the time that he was born from his father's record
into his own Bible, which he now has in his
possession showing that he was born on the
said 22nd day of Oct. 1761. That some time
after the revolutionary war he removed to
Kentucky, where he has lived ever since &
for the last 33 years, he has recollect where
he now resides in the county of Henry &
state of Kentucky - and is well known to John
Lowe & Samuel Demaris -

who reside in his present neighborhood & who will testify
to his character for veracity - that he was
present in the war of the revolution -

He further states that from old age & the consequent
loss of memory, he cannot remember positively - as to the
days of the months on which he entered the service
in his first & 2nd tours - nor the day of the months on
which he was discharged in his 2nd tour - but that
he positively recollects - that in his first tour he
entered the service in the month of April 1767 & that
he was not discharged until the 1st of Sept. 1767. and
he served three months & some days - but that he
claims for three months only, in this tour - that
he recollects, positively, that in his 2nd tour he entered
the service in October 1780 & was discharged in the
month of April 1781 & that he served six months
at the least - and that he recollects positively, that in his
3rd tour he entered the service on the 6th day of July
1781 & was discharged on the 6th day of Oct. 1781. making
in all at least 12 months & for which services he
claims a pension - that he has no documentary
evidence & that he knows of no person - whose
testimony he can procure, who can testify to his
services - He hereby relinquishes every claim whatever to a
pension or annuity whatever, except the present & declares
that his name is not on the pension roll of the agency
of any state - sworn to & subscribed this day & year aforesaid.

of Gray & state of New Jersey & Samuel Demaree
residing in the same, hereby certify that we are well
acquainted with the said Andrew Corning who
has subscribed & sworn to the above declaration
that we believe him to be 71 years of age that
he is reputed & believed in the neighborhood
where he resides to have been a soldier of the
revolution & we concur in that opinion. Sworn
to & subscribed this day & year aforesaid.

On this day personally appeared before the Circuit Court of
the County aforesaid Lydia Gamine a resident of said County,
aged twenty five years, who being first duly sworn according to
law, doeth on her oath make the following Declaration in order to
Obtain the benefit of the provision made by the act of Congress passed
July 7th 1838 intitled an act: granting half pay and pensions to certain
Widows, That she is the widow of Andrew Gamine, who was a pensioner,
and she refers to his Declaration on file, and his last test now in her
possession, she further declares that she was married to the said Andrew Gam-
ine in September seventeen hundred and eighty five, and she further states
that she has a family Record of the ages of her children in the hand writing
of Jacob Picee, in a bible now in her possession, and no Record of her
marriage, and that her eldest son, Richard Gamine (and one of twelve children)
was born on the second day of October seventeen hundred and eighty six
and her youngest was born on the fourth of July eighteen hundred and ten,
and her husband the aforesaid Andrew Gamine died on the eleventh day
of June eighteen hundred and thirty six, that she was not married to him
prior to his serving the service, but the marriage took place prior
to the first day of January seventeen hundred and ninety four (1894) at
the time above stated, and she has remained a widow ever since his death,
and that she has not (nor any person for her) drawn the fraction of pay due
her husband at his death, and that her said husband died in Henry
County Kentucky, and that she was married near Yark town in the
State of Pennsylvania, but does not recollect the name of the County, and does not
not know that there was, or was not a record kept of the marriage -
and that she has lived in Switzerland County and State of Indiana
where she now lives ever since the death of her husband: - Sworn
to and subscribed on the 20th day of April 1861 before the
Circuit Court of Switzerland County and State of Indiana

Dear Madam:

You are advised that it appears from the papers in the Revolutionary War pension claim, W. 9809, that Andrew Conino or Carmine was born October 22, 1781, in New Jersey. His father, name not given, moved to Berkeley County, Virginia, in 1769.

While residing in said Berkeley County, Virginia, he enlisted and served as private with the Virginia troops, as follows: - from April to September, in Captain Robert Little's or Settle's company, under Major William Morgan; from October, 1780, six months in Captain Cuthbert Anderson's company, Colonel Williams' regiment; and from July 6, 1781 to October 6, 1781, in Captain Mc Entire's company, Colonel Darke's regiment.

He was allowed pension on his application executed December 3, 1832, while living in Henry County, Kentucky. He died there June 11, 1836.

The soldier married in September, 1785, near York, Pennsylvania, Lydia, whose maiden name is not stated, and who was born April 19, 1766.

She was allowed pension on her application executed April 20, 1841, while living in Switzerland County, Indiana.
