Taken up by Nathan Rawlings, one Strawberry Roan Mare, seven years old, fourteen & a half hands high, a wart under its right eye, had on a small bell. Said Rawlings lives on Richland Creek, in Harrison County. The Mare is appraised to ten pounds.

Wednesday August 28th 1799.

A Full page letter written by Arthur O'Connor who was in Kilmainham Prison in 1799 in England. The article mentions also a Mr. M'Nevin . Both O'Connor and M'Nevin were Irish and were given the option of leaving country, never to return, if they signed a declaration.

Frankfort, August 15. The trial of Henry Field of Woodford county, for the murder of his wife, came on last Monday week, before the District Court in this town. Greater anxiety in the spectators, who were very numerous, we have seldom seen, than was exhibited upon this occasion. The horrid circumstances attending the atrocious act - the respectable character which the accused had supported, til this lamentable event took place - and the known abilities of the Counsel engaged on both sides - all contributed to exercise a degree of interest in the event of the trial which has seldom been equaled. It continued the whole of the week, and the unhappy man received sentence of death on Monday last. He is ordered for execution on the 19th of next month.

The supposed murderers of the late Mr. Langford, (Micajah Harp and Wiley Harp, who a short time since broke out of Danville jail) we are sorry to learn have added to the black catalogue of their crimes. Authentic information has been received that on the 22d of July, they killed William Ballard, in Knox county, State of Tennessee; and on the 23d, Isaac Coffe (Cosse?). On the 19th they killed James Brazel, near Wolf River in Cumberland Mountain, and on the 31st murdered John Tully in Stockton Valley - They were seen the 2nd of this instant on Marrowbone, a north branch of Cumberland River. We are happy to hear they are closely

pursued, and sincerely hope they will ere long meet the punishment which the atrocity of their crimes demand.

Cincinnati, August 20. It is with great pleasure we inform the public that a principal chief of the Shawnees and three others, came to this place on Friday last, and have given assurances to the Governor, that their nation, and as far as they know, all the others are perfectly friendly to the Americans. That the frontier having been evacuated by them, and the people drawn together to build forts, had distressed them & added to the alarm they were under about the Chickasaws, who as they had been informed were coming in great Force to attack them. That the being in arms at their towns was with no other view than to defend themselves against the Chickasaws, and that they had brought their women and children into them, and were making some fortification about them for their security. That the sole and of their coming here at this time was, that the people might be satisfied they had no bad design against them, and that Neiminsic another chief well known to them, had gone to the Great Miami, to give the people the same assurances.

It is probable he is not stolen or stopped he will make for Mason county where he was raised. Whoever takes up said Horse, and the Thief apprehended, shall have the above reward, and reasonable charges paid, for the horse only three dollars will be given. John Hopkins. Mason, County.
