I give, devise and bequeath all my estate and property, real and personal as follows: To my wife, Eula Fortney, during her natural life, The Home Place located on corner Third and Broad streets, at her demise it is to go equally to all my heirs at law.

To my son, Carl Wright Fortney, there is to be deposited in some responsible bank or Trust Company, at the best possible interest which it can command, six thousand dollars (\$6000.00). The interest to be applied toward the maintainance and education of aforesaid Carl Wright Fortney. In case of his demise or of his attaining his majority (twenty one years of age) The Six Thousand Dollars (\$6000.00) shall be divided equally among my heirs at law. The remainder of my property, real and personal is to be divided equally among all my heirs at law.

Should any of my heirs at law contest this, my last will and testament, that heir shall thereby forfeit its inheritance, excepting Five Dollars (\$5.00) and its part of the estate shall be equally divided among the remainder of my heirs at law.
