FIRST. I desire that all of my just debts, my funeral expenses, my bills for medicine and doctors be paid as soon after my death as practicable, however, I do not want any of my property sacrificed in any way in order to take care of these obligations.

SECOND I will and bequeath unto my Mother, Mrs E. Zaferopoulos, of Vello, Corinthian, Greece the sum of One dollar, this to be her entire interest in my estate, real personal or otherwise.

THIRD. I will and bequeath unto my Brother, John Zaferopoulos, of Vello, Corinthian, Greece, the sum of One Dollar, this to be his entire interest in my estate, real, personal or otherwise,

FOURTH I will and bequeath unto my Brother, George Zaferopoulos, of Vello, Corinthian, Greece, the sum of One Dollar, this to be his entire interest in and to all of my estate, real, personal or otherwise.

FIFTH I will and bequeath unto my brother, Jim Zaferopoulos. the sum of One Dollar. this to be his entire interest in all of my estate, real, personal or otherwise. His address is Vello, Corinthian, Greece.

SIXTH. I will and bequeath unto my Brother, Nick Zaferopoulos, of Vello, Corinthian, Greece the sum of One Dollar, this to be his entire interest in my estate, real, personal or otherwise.

SEVENTH: I will and bequeath unto my Sister, Katherine Arbanitidis, of Vello, Corinthian, Greece, the sum of One Dollar, this to be her entire interest in all of my estate, real, personal or otherwise.

EIGHTH. I will and bequeath unto my sister, Miss Olga Zaferopoulos the sum of One Dollar, this to be her entire interest in and to my entire estate, real, personal, or otherwise. Her Address is Vello, Corinthian, Greece.

NINTH. I will and bequeath unto my Sister, Miss Christina Zaferopoulos of Vello, Corinthian, Greece, the sum of One Dollar, this to be her entire interest in my estate, real, personal or

TENTH. I will and bequeath unto my Brother, Constantine Zaferopoulos, of Vello, Greece State of Corinthian, the sum of One Dollar, this to be his entire interest in my entire estate, real, personal or otherwise.

ELEVENTH: I will and bequeath unto my beloved wife Vaciliki Mike Poulos of Central City, Muhlenberg County, Kentucky, the entire balance of my estate, be the same real, personal or otherwise, and particularly I will unto my beloved wife who is known as Kiki Poulos, although her name

real name is Vaciliki Mike Poulos, my entire business known as the Peerless Cafe and is located on the Northerly side of Broad Street between Locust Street and the L.&NRailroad, in Central City, Kentucky. This business is housed in my building as shown by my deed recorded in Deed Book No 140 on page 557. She shall immediately enter into possession of this building, and this business known as the Peerless Cafe, and any bank or banks shall immediately after my death turn over to her all cash that I may have on hand, to the end that she be able to carry on the business of the Peerless Cafe, if she so desires. She can do this very well as she has assisted me in the conduct of this business ever since our marriage. If she desires to sell any or all of the property that is her right and privilege. In other words she shall have perfect title to every thing of which I may die seized or possessed after the debts, funeral expenses and small bequests have been taken care of, as hereinbefore set out.

The proceeds from all Life Insurance Policies shall go to her at once and shall pay off any indebtedness that may be on the property to the end that she discontinuēngaying interest.

This is best for her.

In order that she may be able to at once take possession of everything of which I may die seized or possessed I am making this Last Will and Testament, in duplicate, one to be filed with the court and properly probated, the other to be used by my beloved wife during the time that will expire between the date of my death and the date of probaton of my will. I am a resident of Central City, Muhlenberg County, Kentucky, therefore, this my Last Will and Testament shall be probated in Muhlenberg County, Kentucky, and said Will shall be recorded in the office of the Clerk of the Muhlenberg County Court at Greenville, Kentucky. There shall be no change in this place of probaton and recording, regardless of the place where I might pass away.

I hereby appoint my dearly beloved wife, Vaciliki Mike Poulos, Executrix of this my Last Will and Testament, she to act as such without bond.

I also appoint my dearly beloved wife, Vacil~~iki~~ Mike Poulos Administratrix of my entire estate, she to act as such without bond. No inventory shall be required or made of my estate. No inventory is necessary as my entire estate left after paying my just debts and the small bequests, hereinbefore mentioned, shall become and be the sole property of my beloved wife, Vaciliki Mike Poulos.

My dearly beloved wife, Vacilik~~a~~, Mike Poulos, shall have all right, power and authority to sell and dispose of this property as she may deem proper. She shall do as she likes about the business. She may run it or sell it, and if she desires she may sell the building and do as she please. In order that there may be no question about her complete and perfect title in and to all of my estate, real, personal or otherwise of which I may die seized or possessed I have this day executed a deed unto my greatly loved wife, Vaciliki Mike Poulos in which deed I convey unto her, only after my death, all of the property of which I may die seized or possessed, be the same real, personal or otherwise. Under and by virtue of this my Last Will and Testament and under and by virtue of this said deed <sup>SHR</sup> shall convey the business, and the property, if she so desires, and have the bank account turned over to her just as an individual. She has full authority, exactly the same as I now have to do with all my property as I please, to handle it as she pleases after my death.
