- . I, Herman Rothert, of Louisville, Kentucky, do hereby make, publish and declare this to be my last will and testament, revoking all others heretofore made by me.
- I. Having full faith and confidence in the judgment and discretion of my beloved wife Franziska Rothert and realizing the large share she has contributed by her labor and management in the accumulation of what property I may be possessed, I hereby devise and bequeath to my said wife Franziska Rothert, all my estate, real and personal and mixed, of whatsoever kind, situate either in the State of Kentucky or the State of Indiana, or within or without the limits of the United States, and I hereby invest her with full power to sell and dispose of the same at her discretion and to control and manage the same as I could do if I were living.
- II. I appoint my wife, Franziska Rothert, to be sole executrix of this my last will and testament and I hereby request both the Courts in the State of Kentucky and in the State of Indiana, to require no bond of said Franziska Rothert, for the faithful performance of her duties as executrix.
- III. I hereby direct that my said executrix shall not be required to file any inventory or appraisement of my estate, either in the State of Kentucky or Indiana, or elsewhere.
- IV. I hereby request my said devisee and executrix, in any division she may deem proper to make of my estate, to consider the advances which I have heretofore made to any of my children, the nature and amount of which she is thoroughly informed, and I know that she will make among them, should she survive me, such distribution as will be just, fair and equitable, controlled as she will be by that love we bear alike to all our children.
