

COMMONWEALTH OF KENTUCKY,

I, John W. Stuart, of Beech Creek, Muhlenberg County, Kentucky, being over twenty-one years of age, and of sound mind and disposing memory make this, my last will and testament. After my just debts have all be paid, I give, devise and bequeath all my property, real and personal as follows:

1. To my wife, Mrs. Ellen Stuart, I give One Thousand Dollars in cash and the house and lot at Beech Creek which we now use as a residence during her life time and at her death it is to be sold and the proceeds distributed among my other heirs as set forth in paragraph Four (4)

2. To each of my six living children, Lillie J. Stuart Tipton, Bettie Stuart Jernigan, John B. Stuart, Lewis H. Stuart, Frank S. Stuart and Horace A. Stuart, I give One Thousand Dollars.

3. To Wilbur Jernigan, Estell Jernigan and Pauline Jernigan Trulove, children of my daughter Lula Stuart Jernigan, deceased, I give Two Hundred Dollars each. To Chas Hughes Trulove, son of Pauline Jernigan Trulove, I give Ten Dollars. To the four childred of Ida B. Stuart Eades, deceased, I give the sum of Two Hundred Dollars each.

4. After these bequest have been paid it is my will that all the remainder of my property, real and personal, shall be divided equally among the following, heris: My wife Mrs. Ellen Stuart, my daughter, Bettie Stuart Jernigan, my daughter, Lillie J. Stuart Tipton, mys sons John B. Stuart, Lewis H. Stuart, Frank S. Stuart and Horace Stuart. At the death of my wife, Mrs. Ellen Stuart, the home place is to be sold and the proceeds divided equally among my six children as set out above.

5. I hereby name and designate as executors of this will my two sons Lewis H. Stuart and Horace A. Stuart and empower them to sell and

make title to any real estate of which I may die possessed, if necessary to winding up and settling of my estate.

In witness whereof, I have signed, published and declared this instrument as my last will and testament, hereby revoking any all wills and testaments that may have been made by me, in the county and State aforesaid, this the 19th day of November, 1924.
